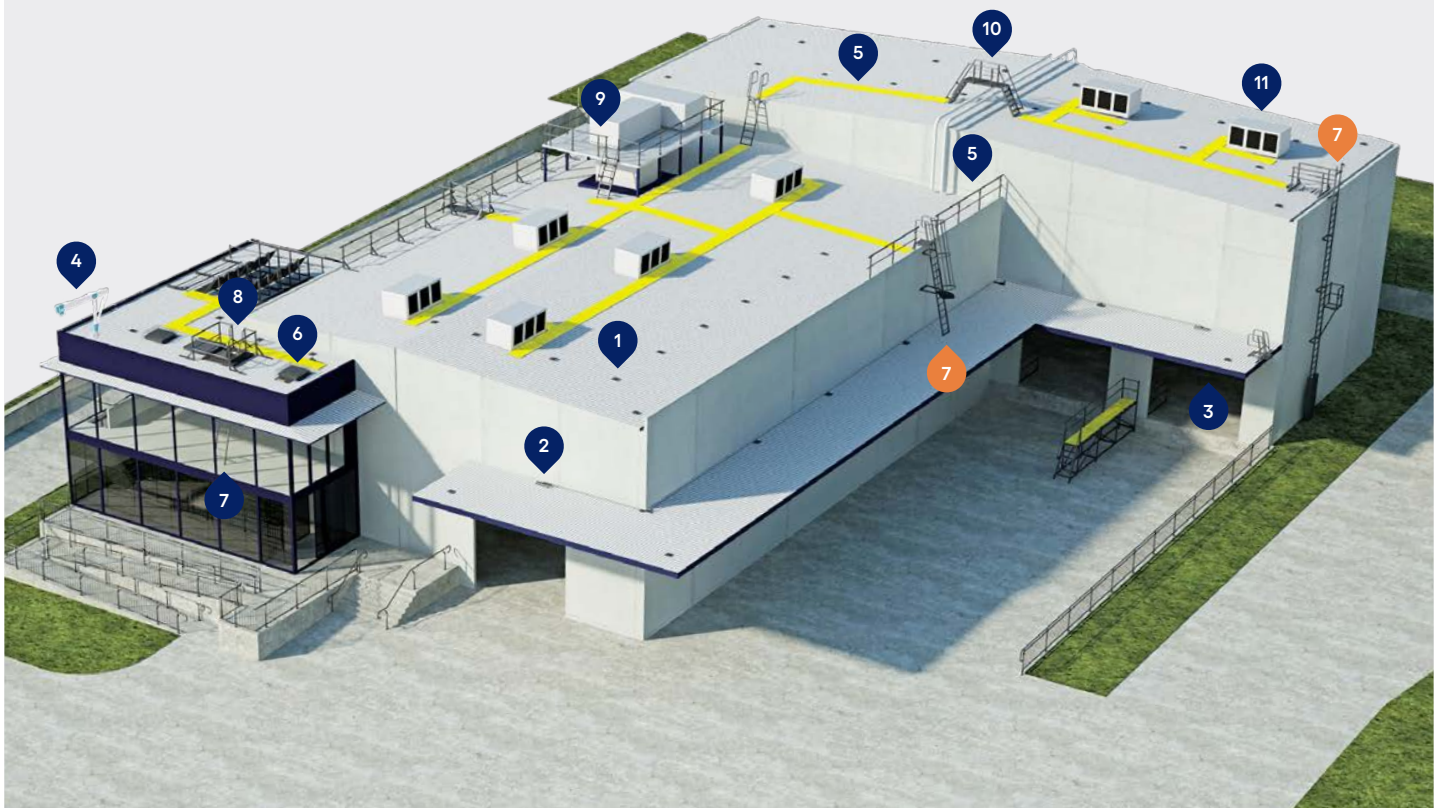

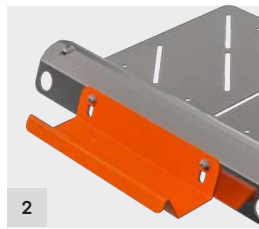
# LADDER SUPPORT BRACKET

Provides additional facility to secure ladder.



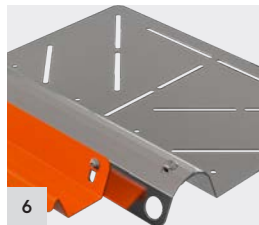
## Fixing slots

Ensures easy location for attachment to structure.



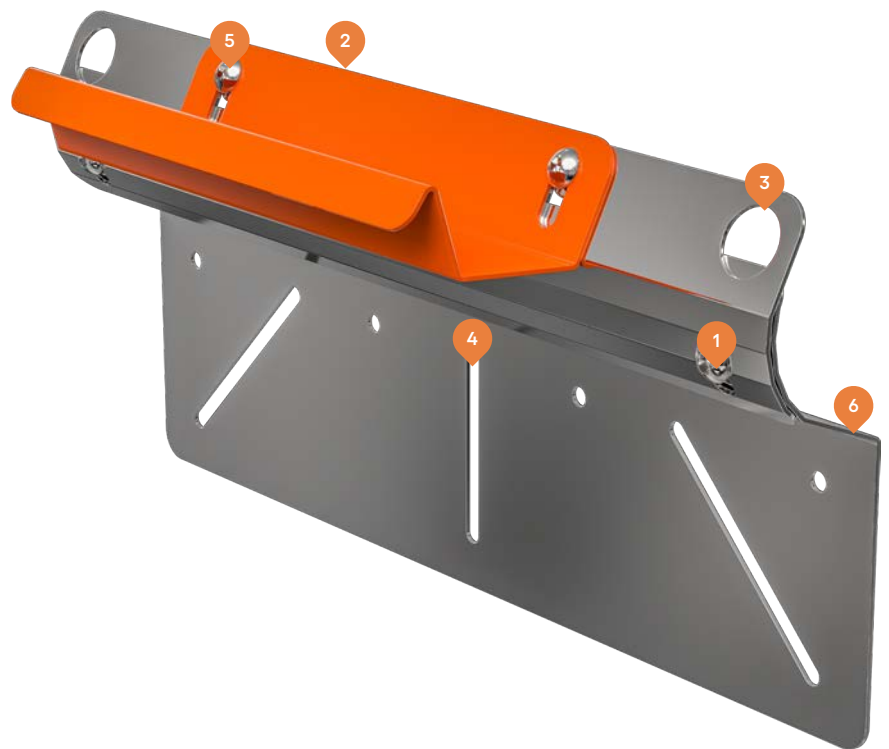
## Ladder angle adjustment

# INSTALLATION REQUIREMENTS

## Must be read prior to installation

1. Read installation and operating instructions carefully before commencing any work.
2. Conduct an initial work/risk assessment, and take all reasonable precautions to eliminate or reduce potential hazards and risks during the installation of this product.
3. Complete all necessary OH&S documentation, including a Job Safety Analysis and Work Method Statement & obtain consent from responsible person in workplace prior to commencement of work.
4. Installers must possess valid industry licenses, be appropriately trained, and comply with all relevant OH&S legislation during installation of this product.
5. Ensure support structure to which unit is attached, will sustain necessary design loads. (Prior approval may be required from a qualified engineer unless it is clear to a competent person that the structure is adequate.)
6. Do not modify or remove any existing structural component or product without prior authorisation by manufacturer or qualified Engineer.
7. Appropriate temporary access and safety equipment must be used during installation, such as platform ladders or scaffolding and fall protection anchorage points.
8. In case of emergency/rescue, unit must be installed by a minimum of two persons.
9. Do not tamper with, modify or remove any part of unit unless authorised by a responsible person.
10. All Kattsafe products and systems must only be installed by competent and Kattsafe accredited persons.

# SYSTEM LIMITATIONS

## Must be read prior to installation

1. The Kattsafe ladder support bracket is suitable for single (1) person use.
2. Only to be used by competent persons with proof of training by a Registered Training Organisation (RTO) in the use of height safety and fall protection systems.
3. The ladder support bracket must be supported on a firm, level surface capable of withstanding 150kg.
4. The ladder support bracket must extend a minimum of 1000mm above the roof surface/parapet edge/top of the wall to assist exiting the ladder safely onto the roof.
5. The ladder support bracket is to be positioned so that the ladder is resting on the ladder tie off flange and not the mounting structure.
6. It is recommended that the ladder be secured to the ladder bracket using a tie off strap to prevent the ladder being removed whilst in use.
7. Do not tamper with system components.
8. This system is not to be used for tethering or lifting machinery or equipment.
9. The safety system must be recertified by a competent height safety inspector as recommended:
  - Non corrosive/mild environment – 12 monthly
  - Corrosive/harsh environment – 6 monthly (more frequent inspection may be required)



**Kattsafe recommends that persons using fall arrest systems do not work alone in case of an emergency and help is required.**

**Should any part of the system/equipment have been subjected to abnormal loading, use must be discontinued until replaced/recertified by a competent height safety inspector.**



# DESIGN & LAYOUT

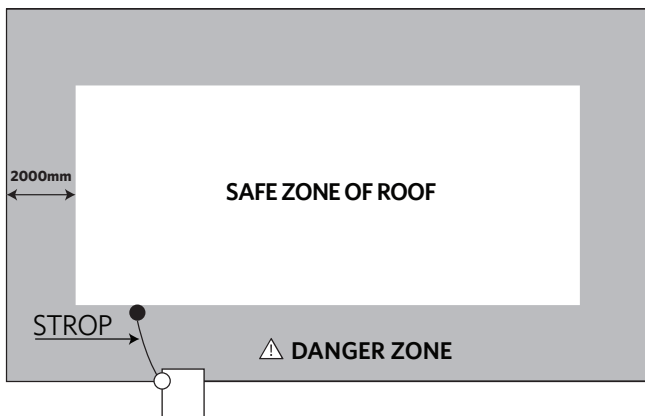
## Must be read prior to installation

1. The hierarchy of risk control must be followed at all times.

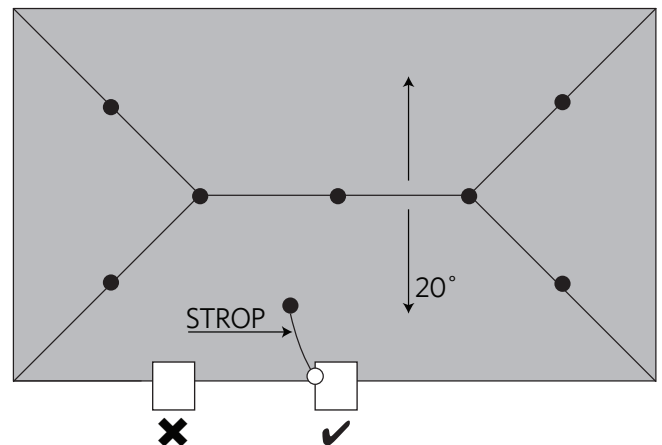


**It is important to note that the lower the hierarchy of control, the greater the skill of the operator required and therefore is least preferred compared with a higher hierarchy requiring minimal operator skill and less risk of operator injury as a result of incompetence.**

2. Professional guidance on the design and set out of this system should be obtained prior to installation.
3. Certain environments produce acidic atmospheric conditions which are detrimental to steel structures and surfaces. Any acidic environment must be assessed and certified by persons prior to installation of this system.
4. Kattsafe recommend that a ladder support bracket is not used above 4000mm due to the instability of a portable ladder above this height.
5. The ladder support bracket must be positioned to allow the operator to exit onto the safe zone of the roof, at least 2500mm away from a fall edge.
6. Kattsafe recommends that an anchor point with a connecting strop be installed at the ladder bracket allowing the operator to connect to the strop via a harness with lanyard prior to exiting the ladder.
7. The ladder bracket should not be positioned within the vicinity of any pedestrian access doors to avoid collision with the ladder.
8. The ladder bracket should be positioned to allow a 1 in 4 (75°) incline of the ladder



Position ladder to exit onto safe zone of roof at least 2500mm from a fall edge.



Kattsafe recommends that the entry point to a roof should be positioned to provide the shortest route to all locations on the roof.

Where the operator is required to be constantly attached to the fall arrest system and the lengths of the travel is beyond 15m, Kattsafe recommends that additional access points be provided rather than increasing the rope lanyard length which will become heavy and cumbersome to use.

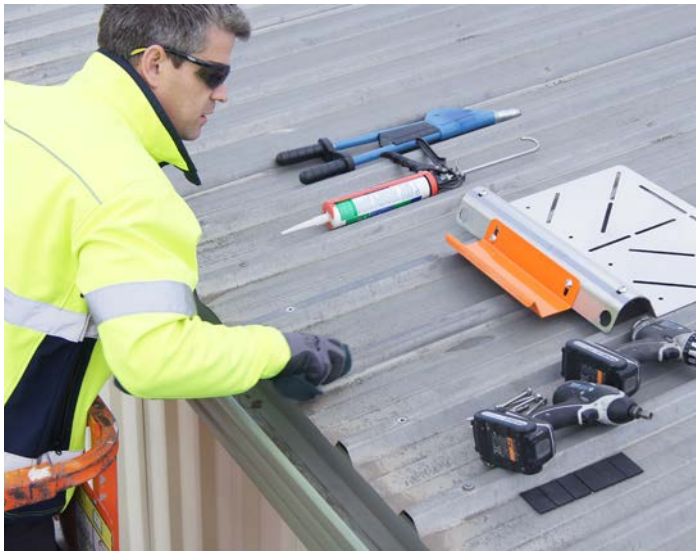

# INSTALLATION PROCEDURE

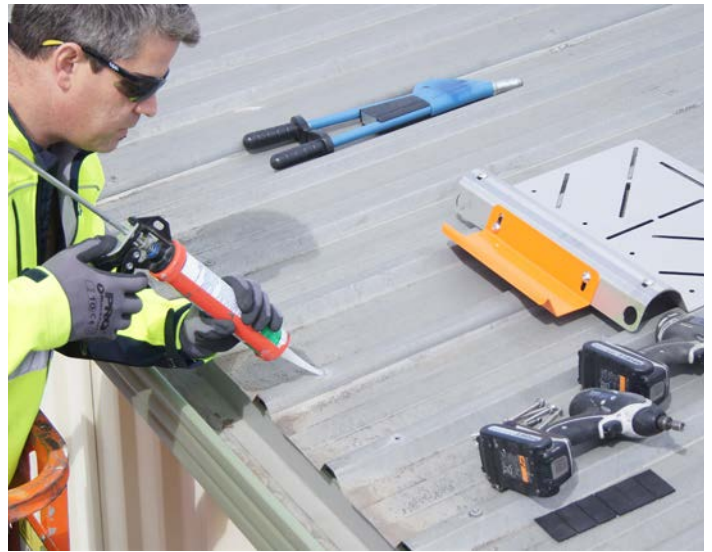
## Step 1

Identify suitable location of bracket.



## Step 2

Remove existing roof screws and seal off holes.



## Step 3

Position ladder bracket and secure using 14 gauge tek screws x 3. The bracket should be positioned so that the ladder is resting on the ladder tie off flange and not the gutter or fascia.

⚠ Apply a generous bead of silicone around the screw penetrations prior to securing the tek screws.



## Step 4

Drill remaining 3 x 8mm holes and secure using 3 x 8mm bulb tite rivets x 3.

⚠ Ensure silicone or is applied to penetration area prior to inserting rivets.

### Step 5

Adjust ladder support to sit level in all four directions so as to best secure portable ladder.

### Step 6

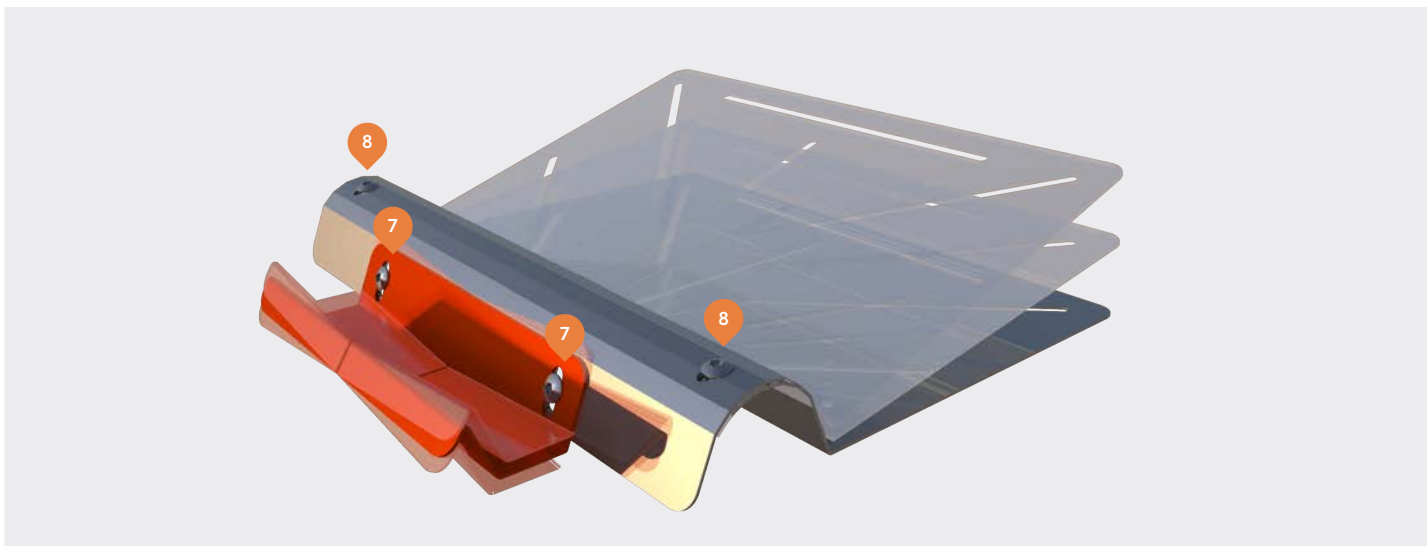
Attach relevant access and warning signage.



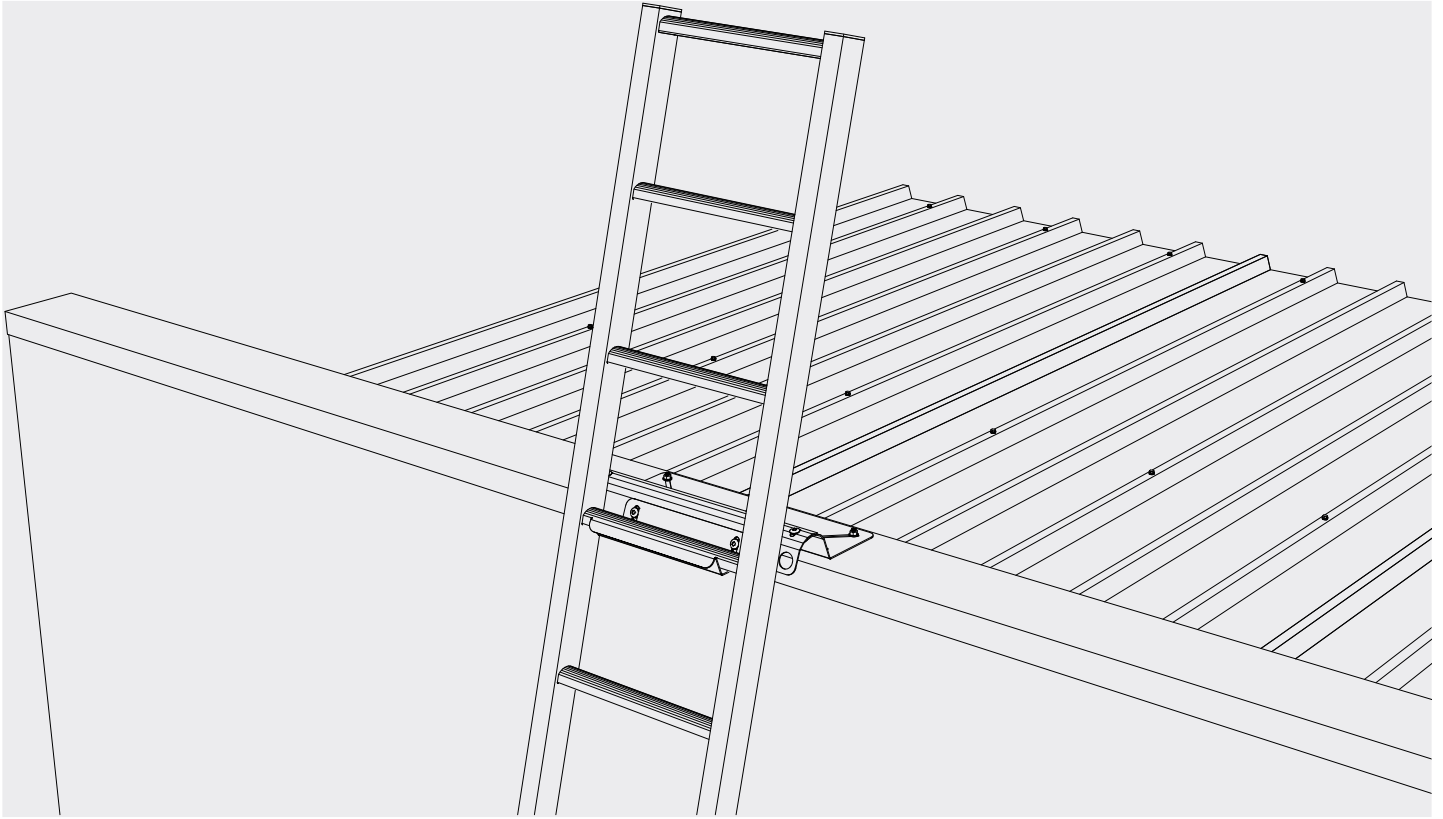

### Step 7

Support bracket mounted on an angle requires the ladder support to be levelled to ensure best support for portable ladder.



# PARAPET MOUNT INSTALLATION PROCEDURE

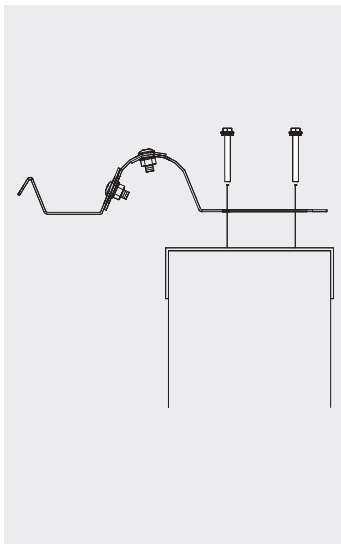
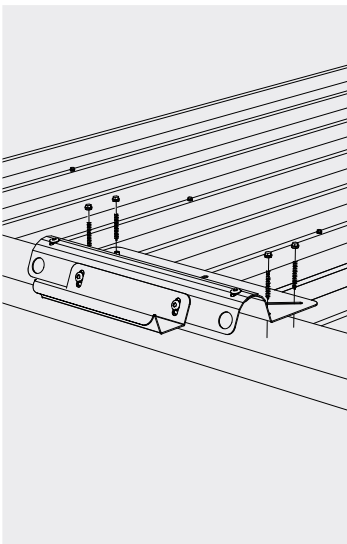


## Step 1

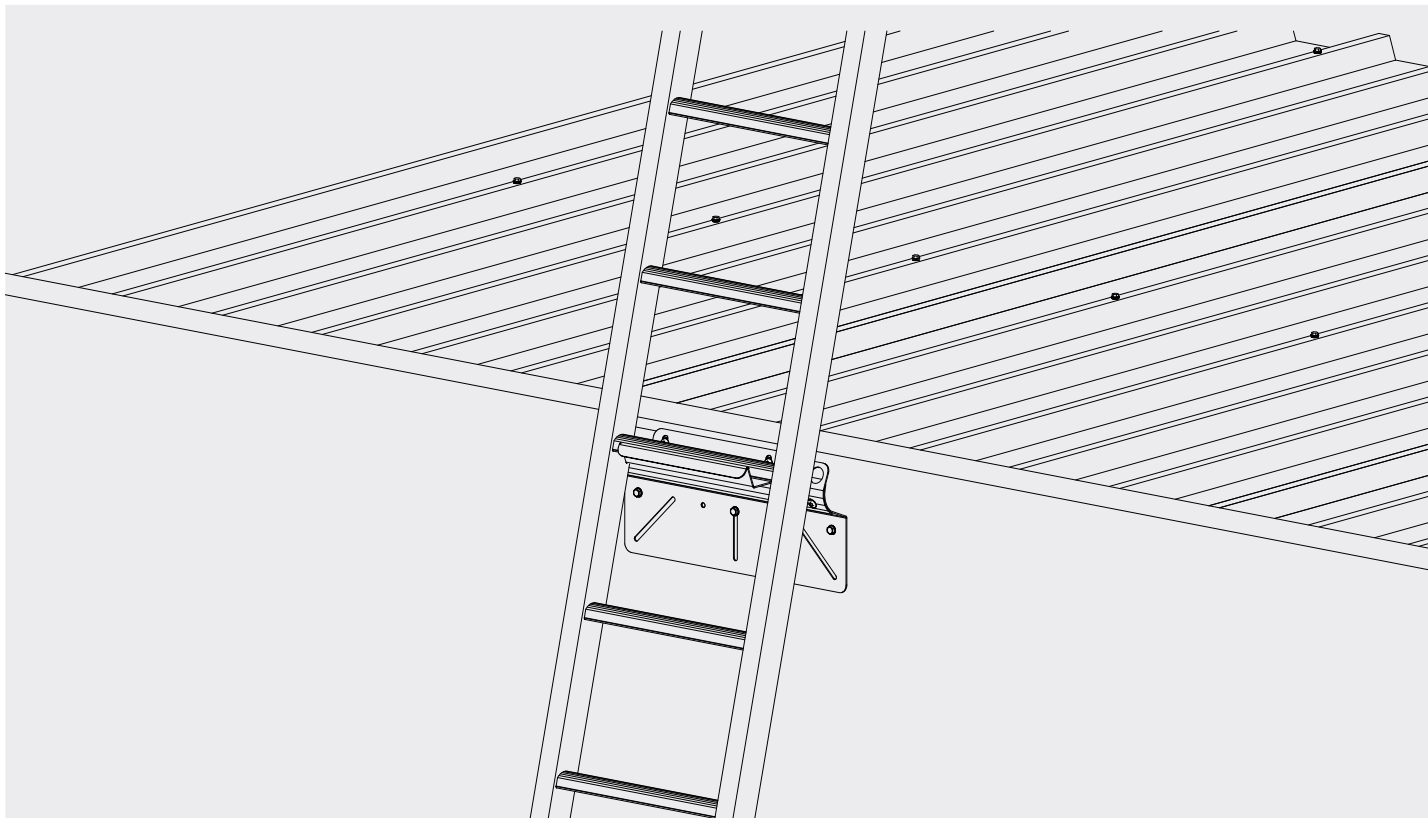
- Fix to concrete structure using 8mm x 75mm screw bolts x 3
- Fix to timber structure using 14 gauge x 75mm tek screws x 4
- Fix to steel structure using 8mm bolt set or 14 gauge x 75mm tek screws x 3

Follow previous steps 5 - 8



# WALL MOUNT INSTALLATION PROCEDURE

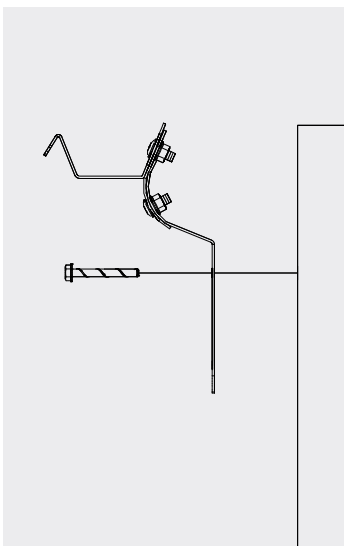
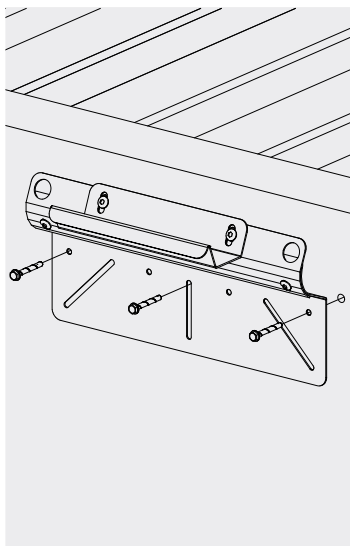


## Step 1

- Fix to concrete structure using 8mm x 75mm screw bolts x 3
- Fix to timber structure using 14 gauge x 75mm tek screws x 4
- Fix to steel structure using 8mm bolt set or 14 gauge x 75mm tek screws x 3

Follow previous steps 5 - 8

# SYSTEM MAINTENANCE

## Must be read prior to checklist

1. The ladder support bracket needs to be checked and recertified by a competent height safety inspector every 12 months for non corrosive environments or 6 monthly for corrosive or harsh environments. (To be determined by competent person depending on severity of surrounding conditions.)
2. Never clean using acids or other chemicals that could damage the system components.
3. Ensure all fixings into the support structure are secure and the adjustment pitch and angle locking screws are secure.
4. The identification label must be completed to confirm recertification has been carried out.
5. Any deterioration or damage to the system or equipment must be reported to person in control of the workplace and relevant corrective action undertaken.
6. Maintenance inspections must be clearly documented. Any non-conformance must be clearly identified and tagged 'Do Not Use' until corrective action by a competent person.








# MAINTENANCE CHECKLIST

The checklist below outlines key checking criteria required to ensure the safe use of this system. Any item of concern not shown on the checklist must be noted on the maintenance report and brought to the attention of the workplace manager.

Items ticked PASS - YES means they conform with the required checking criteria and are suitable for normal use until the next recertification date. System data plates must be updated showing current check date and next check date.

Item ticked PASS - NO means they do not conform to the required checking criteria. These items must be clearly tagged 'Do Not Use' and the required corrective actions put in place. The maintenance report must clearly document all non-conforming criteria.

 **This system must be maintained by a competent height safety inspector trained in the safe use and maintenance of this system.**

# TECHNICAL SPECIFICATION

## Ladder support brackets

### LD401, LD402

Ladder support bracket which provides a secure attachment point for portable ladders. System design, supply, layout, installation and certification by a Kattsafe approved installer, as per the manufacturer's installation instructions and current standards.

#### Materials

Profiled stainless steel, powder coated

#### Dimensions

LD401: 480 (W) x 160 (D) x 240mm (H)

LD402: 480 (W) x 480 (D) x 70mm (H)

#### Weight

LD401: 2.3kg

LD402: 3.7kg

#### Fixings (refer to installation manual)

- Timber fixing: 14g/type 17 Tek screw x 4
- Metal fixing: 8mm bulb type rivet x 6 OR 14g into structure x 4
- Concrete fixing: 8mm x 75 screw bolt x 3 OR wedge type anchor x 3
- Steel structure: 8mm bolt set x 3

#### Substructure requirements

Support structure integrity, suitability and fixing method to be assessed and determined by a competent person prior to installation.

#### Rating

- 150kg rated, single person use

#### Compliance

Kattsafe ladder brackets are designed to conform with requirements of the Australian & New Zealand Standards AS/ NZS 1657:2018 and AS/ NZS1891 and relevant codes of practices and guidelines.

#### Testing

Testing and performance based on single person use (max 120kg) using an Australian Standards approved portable ladder.

#### Product warranty

10 Years from date of purchase subject to correct installation. Use and maintenance to be in accordance with manufacturer's specifications and recommendations.

#### Inspection and maintenance

Visual inspection for any damage or loose fixings must be done periodically and prior to use. No certified maintenance required. Basic wear/ tear preventative maintenance is recommended, as per manufacturer's specifications and recommendations (refer installation manual).

#### Important note

Failure to supply and/or install proprietary product in accordance with above standards and codes, specifications and instructions voids complete system certification and/or warranty

Systems/components used for purposes other than their intended use will void warranty.

General wear and tear is expected and will depend on the frequency of use and is not covered by warranty.
